These Terms of Use (these “**Terms**”) govern your access and use of the resources on the RILM platform (the “**Site**”), made available to you by Répertoire International de Littérature Musicale, Inc. (“**RILM**,” “**we**,” “**us**,” or “**our**”).

By accessing or using the Site, you acknowledge that you have read, understand, and agree to these terms and our [Privacy Policy, which is a part of these terms](#). Do not access or use the Site if you do not agree with these terms or our [Privacy Policy](#).

We may make changes to these terms from time to time. If we do, the changes will be effective immediately upon posting to the Site and, by accessing or using the Site after changes are posted, you agree to those changes. We will conspicuously post any material changes.

1. **Privacy Policy.** We may collect certain information from your use of the Site as set forth in our [Privacy Policy](#). By using the Site, you consent to the information collection, use, and sharing as set forth in our [Privacy Policy](#).
2. **Permitted Use.** You may search, retrieve, display, print, and retain small portions of the content to which you have access (which, unless you are an authorized user of a subscribing institution, is limited to previews of certain content) solely for purposes of:
 - i. academic, scholarly, or educational research;
 - ii. classroom or organization instruction;
 - iii. student assignments;
 - iv. academic, scholarly, or educational presentations, lectures, seminars;
 - v. research paper or a dissertation;
 - vi. similar activities; and
 - vii. on an occasional, noncommercial basis to share limited and discrete content with others in order to collaborate, comment, or to exchange ideas related to shared research interest; public display as part of a noncommercial scholarly or educational presentation, e.g., educational, cultural, or scholarly seminars, classes, lectures, conferences, exhibits, or workshops, or a similar noncommercial professional activity, provided the use conforms to the customary and usual practice in the field.
3. If you are an authorized user of a subscribing institution, you may also (1) download and print selected portions of content solely for noncommercial use, provided you do not modify or delete any copyright, trademark, or other

proprietary notices, (2) request and, with RILM's prior written consent, use content for data mining, and (3) create annotated materials using content solely for the purposes listed above. As an authorized user of a subscribing institution, you also have the option to set up an individual account. Setting up an account allows you to access certain functions (e.g., the ability to save bookmarks). You are responsible for maintaining the confidentiality of your username and password.

4. **Use Restrictions.** Except as expressly permitted above, you may not:
- i. copy, reproduce, display, duplicate, sell, publish, post, license, distribute, or create derivative works of all or any part of the Site without the prior written consent of RILM;
 - ii. incorporate any part of the Site into any database or other website;
 - iii. use the Site for unlawful purposes;
 - iv. access, use, or copy any portion of the Site through indexing agents, spiders, scrapers, bots, web crawlers, or other automated devices or mechanisms;
 - v. use the Site to post or transmit any material that contains any viruses, Trojan horses, worms, time bombs, cancelbots, malware, adware or other computer programming routines that may damage, interfere with, surreptitiously intercept, or expropriate any system, data, or personal information;
